Terms & Conditions:

1. The proposal and the payment is for the usage of up to three months. Only one proposal per user will be enabled at a time.
2. The user can request up to the limits mentioned in the above table. The actual allocation will depend on the demand at the time of the request.
3. The computations for the amount paid will have to be carried within (three months plus grace period of one month). Under no circumstances, any part of the amount will be refunded.
4. 10% of the overall requirement will be provided for free. This can be used for testing and debugging.
5. The computations cannot be used for space and defense research.
6. The computations cannot be for commercial purposes including development of commercial products.
7. The account will be disabled either at the end of four months (if computations not performed) or at the end of the computations exhausted against the amount paid.
8. It is the user’s responsibility to remove the data within five days of the disabling of the account.
9. The user will duly acknowledge the use of the HPC facility in any publications that have used SERC, IISc HPC resources.
10. The user also agrees to submit a 3-page half-yearly report on the project which uses the HPC facility at SERC.
